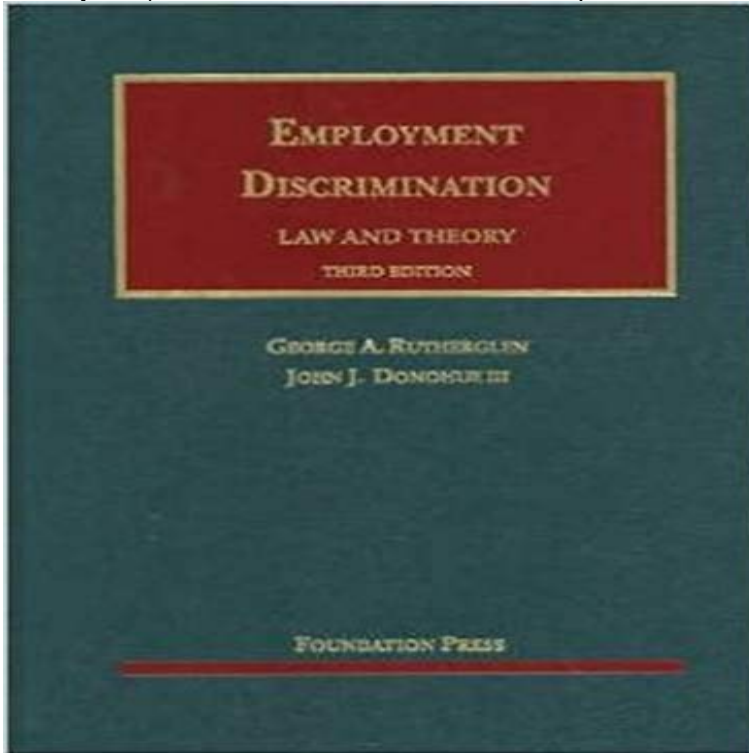


## Employment Discrimination (University Casebook Series)
