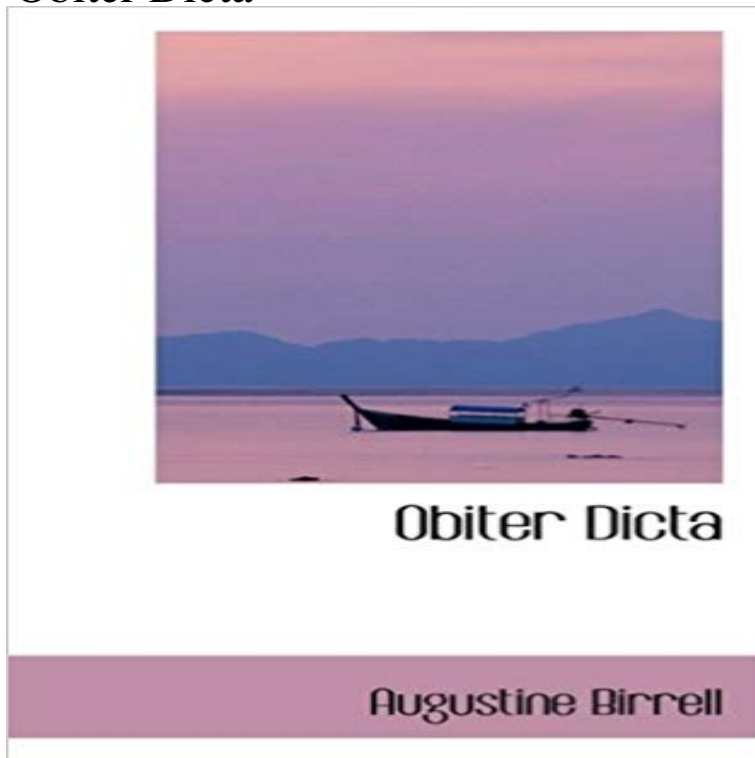


Obiter Dicta
