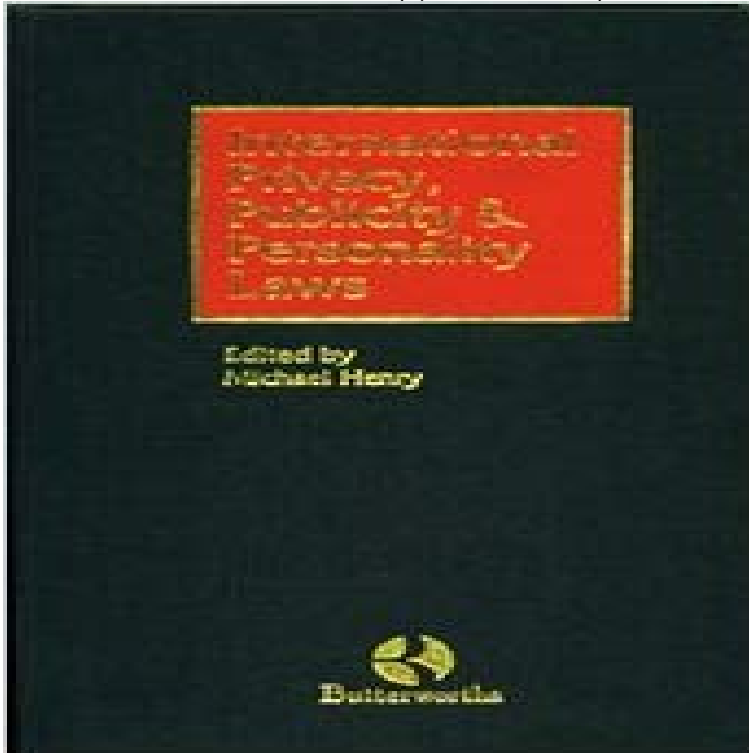


International Privacy, Publicity and Personality Laws
